Fire Stations

- HVAC nearly completed with large improvement noted
- Electronic sign: revised drawing after awarding bid by staff. Changes result in approximately \$10K in additional costs if accepted by the Board. Drawings in packet.
- Received two bids for the roof replacement project, both significantly higher than initially anticipated. Roof consultant Gary Patterson presented bids and explained the increase of costs
- Revised costs of Station 2 refresh to be discussed at June BOT meeting

## <u>Grants</u>

- AFG Grant for radios pending. Starcom needs seem to be growing locally. Possibly Lake County ETSB grant would provide for 13 portable radios worth more than \$100K
- SCBA Grant was awarded to MES. Order for equipment will be completed shortly

## Apparatus

- Finalized IGA with Mundelein to perform fleet services on Engines and Ambulances for approval pending final attorney approval
- New Dodge Rams for FPB have been delivered and are scheduled to be outfitted with lights/radios/stickers soon.

A motion was made by Trustee Kiriazes and seconded by Trustee Davenport to confirm the district board decided to select the alternative bid and directed the fire chief to work with the consultant to award the Station 2 Roof Replacement Bid to the bidder who can begin the work quickest.
