CFPD was awarded the runner-up award for the contest sponsored by Allstate for a \$3000 prevention grant.

# Apparatus & Equipment

The 2001 and 2003 Pierce Engines have major frame rail corrosion. Staff continues to work with Pierce regarding warranty resolution.

The Ladder Tower completed its 10-year maintenance trip to Minnesota and is back in service.

The new AEV ambulance should arrive next week and be in service within a couple weeks. D/C Smith and B/C Wodrich made the pre-delivery inspection trip to Jefferson N.C. this past week.

## **Programs**

Audit - The FY 2016-17 on-site audit work has been completed and will be presented at the December 15, 2017 meeting by the auditor.

Staff is working with insurance brokers on our 2018 renewals. This includes, property and casualty, liability, worker's compensation, accident/illness, medical, dental, vision, and life.
