Grants

The District employed the services of a grant writer to review both grant applications.

CFPD is applying for an IL State Fire Marshal Small Equipment Grant for rescue tools.

Apparatus & Equipment

The contract with Pierce for the new engine has been signed and financing is in progress. Staff is meeting

with Global Fire Equipment (GFE) Representative on final design and specifications.

One of our ambulances was involved in a crash while enroute to the hospital on 1/20/18. There were no injuries. The driver of the other vehicle was cited for failure to yield to emergency vehicle. The ambulance

is out of service pending repairs for 4-6 weeks.
