CFPD is applying for an IL State Fire Marshal Small Equipment Grant for rescue tools.

## Apparatus & Equipment

The contract with Pierce for the new engine has been signed, financing secured and payment made.

The ambulance that was involved in a crash is in the shop for repair and should return to service shortly.
