## Attorney's Report

John Kelly of Ottosen Britz Kelly Cooper Gilbert & DiNolfo, Ltd. reported on and discussed the following items:

Extending settlement offer with objectors attorney for 2011 Tax Objection.

The Illinois Senate has passed a property tax freeze bill and has sent it to Illinois House for discussion. The freeze would be in place for fiscal year 2016 and 2017 and contains a public safety exemption as currently interpreted. No action has been taken on this bill.

HB4305 to release 9-1-1 funds has support from the Democrats but none from the Republicans. A lawsuit is pending in St. Clair County for immediate release and may lead to similar lawsuits.

Tax levy to be filed at the November or December board meeting subject to the black box provision.
