## About Countryside Fire Protection District

The District was organized in 1959 under the general laws of the State of Illinois providing for the organization and operation of fire protection districts. Countryside staffs two fire stations 24 hours a day and in 2024 responded to 5,414 fire, rescue and EMS calls. The District is an internationally accredited fire agency, meeting the highest standards set by the Commission on Fire Accreditation International and is rated a Class 2 by the Insurance Services Organization (ISO). The District located in Lake County Illinois stretches from Milwaukee Avenue on the East and to Fremont Center Road on the west. The Northern most boundary is Winchester Road, and to the south, Port Clinton Road. The Canadian National and METRA Railroads traverse the District. The District provides a full range of services to its 36,384 residents. Our professional force of 46 full-time Firemedics train frequently to ensure readiness for those various services including fire suppression services, emergency medical services, underwater rescue and recovery, hazardous material response, fire prevention and public education, special rescue and community events.
