**ORDINANCE NO. 2023-O-05**

**ORDINANCE LEVYING AND ASSESSING TAXES OF THE  
COUNTRYSIDE FIRE PROTECTION DISTRICT  
LAKE COUNTY, ILLINOIS FOR 2023**

BE IT ORDAINED by the Board of Trustees of the Countryside Fire Protection District, Lake County, Illinois, as follows:

Section One: That the sum of **TWELVE MILLION, TWO HUNDRED FORTY-FIVE THOUSAND, TWO HUNDRED AND TWENTY-EIGHT DOLLARS AND NO CENTS (\$12,245,228.00)** assessed and levied from and against all taxable property within the limits of the said Countryside Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2023, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:
